4. The application will be presented before the Membership Committee for review and the decision sent to the Board for approval.
5. After obtaining Board approval, associate members attached to your agency can now apply for membership

**REALTOR-ASSOCIATE®**

1. Must be a licensed real estate salesman
2. Must be attached to a REALTORS® who is already a member of the RAJ
3. Complete the application form. (See below)
4. Submit the completed application form along with required documents which are listed on page 2 of the application form
5. The application will be presented before the Membership Committee for review and the decision sent to the Board for approval.

#### **BREAKDOWN OF PRORATED MEMBERSHIP DUES FOR APPLICANTS**

As indicated, RAJ membership dues are charged in Jamaican **PLUS** American currency and **MUST** be paid at the JN Bank (JN) or Bank of Nova Scotia (BNS) in the currency quoted. Please note that only the US\$ portion of the dues can be paid quarterly or semi-annually. Kindly contact the Secretariat for further details.

All new members are required to attend an orientation session as a part of the process of being accepted as a member of the RAJ. These sessions usually last no longer than five (5) hours and attendees are asked to bring along with them their electronic devices as the sessions will include hands on introduction to the Multiple Listing Service (MLS). After new members have been orientated, they will be inducted and presented with their Membership Certificate. Below are dates of all upcoming sessions.
